Terms & Conditions of Le Pari Dance Fitness Center

By purchasing any of our services online or inside of Le Pari Dance Center, the client agrees to the following:

Group classes:

- 1. Le Pari has a right to cancel any group class with less than 6 students in the class.
- 2. If the class is missed by a student, the payment cannot be credited or transferred to the next week.
- 3. The group class is for 45 minutes long.
- 4. No refunds on any group classes payments.

Private/Wedding lessons:

- 1. All payments should be received in advance. If the payment is not received, the lesson is not confirmed with the instructor & considered cancelled.
- 2. Each lesson is 45 minutes long and includes the setup of the schedule with instructor or any other questions discussed.
- 3. The studio agrees to give dance instructions in accordance with the Le Pari Fitness Dance Center methods and steps and to make its facilities and personnel available to the student for such purpose, which course shall be completed within one year of the date of the purchase except one lesson with 3 months and 5 lessons package with 5 months of expiration. The terms and conditions of this contract remain the same on the purchase of a new dance program by abovementioned student and it doesn't require to resign the contract each time.
- 4. It is further agreed that all lessons shall be scheduled for definite times within the above term, and if the student wishes to cancel or change any appointment for instruction, he shall notify the studio **at least 24 hours in advance** of the appointed time. Failure or neglect of the student to give such prior notice shall cause **such lesson to be charged** to the students' account with the same effect as of the lesson had been used.
- 5. It is further understood and agreed that a **reduced rate of any dance package has** been given to the student because of the number of hours contracted for, and that this contract is entire and is not severable and divisible. If the student has a significant reason to terminate his contract, he needs to provide Le Pari center **with the written proof** of the unavailability on taking lessons. If the package has been agreed on 3 payments plan with the discounted rate, at the termination of the contract the student is obliged to pay additional amount for the used lessons with the rate per one single lesson. If such payment doesn't occur, Le Pari Center has a right to contact the appropriate agencies to receive the owned amount.
- 6. It is also understood and agreed to that this contract is made solely with the above studio as seller and does not constitute any agreement with any instructor. If the student continues with any Le Pari dance program, all terms and conditions of this contract remains the same.
- 7. There is reserved unto the students, the right to cancel private lessons contract within seventy two (72) hours of the date of the purchase, and shall be binding thereafter if not cancelled. There

will **be 7% administrative fee charged** on such a refund. It's noted that all lessons program has terms of expiration. If the package is not used within expiration term, it is considered to be cancelled.

Rentals (Floor fee):

- 1. The rental fee includes the time for setting up & cleaning.
- 2. The payment should be done in advance.
- 3. The renter is responsible for any damages if they occurred on the rented premises.
- 4. Le Pari is not responsible for any lost items.
